With reference to the application dated 10.05.2025 and subsequent recommendations of District Educational Officer (Private Schools), Krishnagiri and school inspection report dated 20.03.2025. in this regard, I hereby convey the grant of Recognition to Advaith International Academy, Innapasadram, Nallur Village, Hosur Taluk, Krishnagiri District – 635 103, **Tamil Nadu** for the class **LKG to XII Standard** for the period up to **18.12.2027** in compliance to Rule 12 of Right of Children to Free and Compulsory Education Act, 2009 and Rules 2011 and maintain the standards and norms as specified in section 19 of the Right of Children to Free and Compulsory Education Act, 2009.

**The Recognition Code Number allotted to the School is 004-19-S-0002-1227**

**The above recognition is subject to the following conditions:-**

1. The temporary recognition accorded to the school is valid up to **18.12.2027** for the classes **LKG to XII** and is to be renewed at the end of three years.
2. The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011. The School shall maintain the standards and norms as specified in section 19 of the Right of Children to Free and Compulsory Education Act, 2009.
3. The School shall not collect any capitation fee and subject the child or parent or guardian to any screening procedure.
4. The School shall not deny admission to any child :-

6. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority
7. No unrecognized classes shall run within the premises of the school or in any other place in the name of School.
8. The School building plan must have been approved by the competent authorities as per relevant rules. The School building or other structures and the land are to be used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respects are the whole responsibility of the school management.

12. The recognition Code Number shall be quoted for any correspondence with the competent authority
13. The School shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition
14. Tamil language shall be taught as a subject in standards I to X as notified under sub clause (iv) of clause (e) of section 2 of the Tamil Nadu Tamil Learning Act, 2006 (Tamil Nadu Act 13 of 2006 as ordered in the reference 4 cited.
15. The School shall abide by the provisions of the Tamil Nadu Private Schools (Regulation) Act 2018 and Tamil Nadu Private Schools (Regulation) Rules 2023 and relevant Acts and rules that are in force from time to time.
16. Infrastructure including sanitary facilities shall be maintained as per the requirement of Tamil Nadu Combined Development and Building Rules, 2019 and related amendment, if any
17. The certificate of recognition issued shall be subject to the rectification of deficiencies if any as pointed out by competent authorities at any stage/time.

25. Drinking water facility, Toilet Facility and Class room should be provided in accordance with student strength.
26. The classrooms and laboratory should be as per the building plan approval. Any alteration in existing classrooms or creation of additional classrooms should be done with the proper approval of the concerned Authorities.
