CREATION OF THE TRUST :

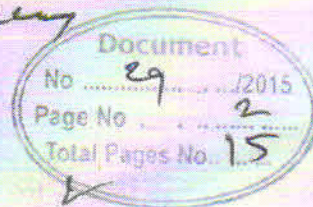

OBJECTIVES OF THE TRUST :

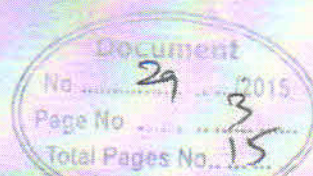
The following are the main objects of the Trust. The Trust shall utilize its income for the objects of the Trust only.

1. The Trust is a public Charitable Trust.
2. To establish, run/aid Educational Institutions, including Schools, Arts, Engineering, Teacher Educational institutions like D.TEd., B.Ed., M.Ed., Phd., Polytechnic, Industrial Training Institutions, Nursing, healthy hospitality of business etc., for the object of education, vocational and charitable pursuits and all other people of India without discriminate to caste, creed, religion or language.
3. To run/aid Hospitals, Primary health Center's for the Poor and downtrodden.
4. To provide poor feeding on auspicious days such as Independence Day, Republic Day and Gandhi Jayanthi etc., to all without discrimination to caste, Creed, religion or sex.
5. To provide free shelter, clothing, Education and food to orphan children and to run orphanage and also Old Age Home for destitute without discrimination to caste, creed, religion or sex.
6. To conduct poor feeding and generally give food, education, clothing, medical are and other aids to the poor needy and disabled persons and to afford relief to people in distress due to natural calamities, accident, earthquake, flood, famine, epidemics and conduct or grant donations for the support of orphanages and welfare institutions.
7. To encourage studies and institute scholarships, prizes, shields etc. for students in any Schools, colleges, educational institutions, Patasalas and Vidhyalayas or for students studying a particular subject or course or those undergoing training in particular field of those engaged in research in any field of creative activity in any part of India.
8. The trust will not carry on any activity with the intention of making any profit.
9. It is further declared that the trust shall not carry on any business, trading activity or activities or with the intention of earning a profit, the aforesaid objects of charity shall be provided to the beneficiaries without distinction of caste, creed, colour sex or religion.

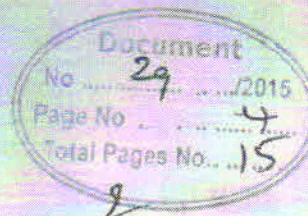
10. To do all such other lawful things incidental or conducive to the attainment of the above objects.
11. To establish cultural and social institutions for linguistic minority people and others.
12. Creating self employment for the both men and women in rural areas.
13. Medical services for the old age people.
14. Creating the awareness to the people about the government schemes through the cultural programs.
15. Creating the awareness about the consumer's protection through conducting programs and meetings.
16. Through the cultural programs and meetings, creating the awareness and also giving training, financial assistance to the women, and protect their rights.
17. Conducting programs and creating the awareness about the HIV AIDS and TB. And also taking care of the suffered people.
18. Blood donation, TB – Importance - conducting medical camps.

24. To establish and maintain a scholarship for the poor and meritorious student by granting scholarship or subsidies without discrimination on any caste, creed or community.

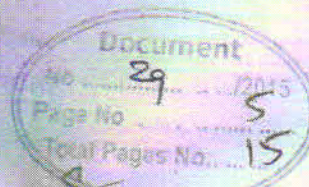


25. To provide medical relief and supply aid and equipment to the physically handicapped or lame persons.
26. To relieve the poor, and indigent men and women of all communities without any restrictions as to caste, community and creed including contracting, maintaining choultries, public halls, for the benefit of the Public free of charge and to feed the poor and needy.
27. To promote sports and other connected activities among the public irrespective of caste, creed and community.
28. To carry out any other activities of General Public Utility.

GENERAL CLAUSE:-

- a) The Trust shall be a public one and shall be irrevocable.
- b) That any amendment of the trust shall be carried out only with the prior approval of the Director of Income tax, Salem.
- c) No activities of the Trust shall be carried out outside India. It shall be strictly carried out within India.
- d) The Income and funds of the trust shall be solely utilized towards Fulfillment of the object of the Trust and no portion of it shall be utilized for the payment or benefits of the trustees of the trust by way of Profit, Interest, Dividend etc.,
- e) The surplus funds of the Trust shall be invested in accordance with the provision 13(I), 13(III) read with Section 11 of the Income tax Act.
- f) To Sell, Mortgage, grant on lease, hire or otherwise alienate all properties of the Trust. No property of the Trust shall be alienated without the prior approval of the Director of Income tax, Salem.
- g) The income of the trust shall not be applied for any religious purposes or given to religious institutions not more than 5% of such income.
- h) The Financial Year of the Trust shall be from 1st April to 31st March. The accounts of the Trust for each financial year will be audited by a duly qualified Chartered Accountant appointed by the Trustees as prescribed in section 16 of the Act. As on now there is no movable or immovable properties in the name of the trust.

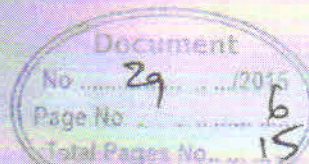
VI. MANAGING TRUSTEES OF THE TRUST:

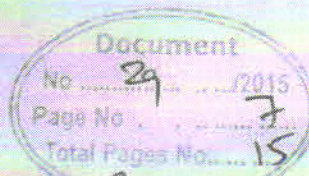
VII. POWERS OF THE TRUSTEES:

- d) To acquire by purchase, grant, gift exchange, lease, hire or otherwise, lands, buildings, movable and properties of ever-other description.
- e) To sell, mortgage, grant on lease, hire or otherwise alienate all properties of the Trust. No property of the Trust shall be alienated without the prior approval of the Director of Commissioner of Income-Tax (Exemptions).
- f) To enter into all contractors on behalf of the Trust and to rescind them.
- g) To borrow money with or without security and to repay the same.
- h) To open accounts in the name of the Trust with Bank or Banks and the same shall be operated individually by the Chairman of the Trust.
- i) To invest all funds of the Trust nor immediately required for the purpose of the Trust in such investments as may be permitted under section 11(5), read with section 13(1) (a) of the Income Tax Act 1961.
- j) To receive collect and enforce of all money due to or payable to the Trust and grant necessary receipts and discharges therefore.
- k) To appoint, terminate, suspend or otherwise deal with the staff employed for the administrations of the Trust.
- l) To appear before courts, Tribunals public officials etc.,
- m) To produce and defend all suits and other legal proceedings.
- n) To incur all necessary expenses in connection with the Trust and its management.
- o) To accept contributions, donations, gift to, legacies or grants to the Trust and from any persons and to hold the same upon Trust and subject to the powers, provisions and stipulations contained in their DEED OF TRUST.
- p) To invest the Trust fund in such a manner as prescribed by Income-tax Act,1961.

- q) To construct new buildings or structure or re-build, improve, enlarge or add to all or any one more of the buildings or structures forming part of the Trust fund at any time.
 - r) To deposits, invest, withdraw, purchase, sell mortgage redeem convert, consolidate, subdivide, renew or otherwise deal with the securities or other assets, movable, immovable properties owned by the Trust.
 - s) To receive gifts, purchase, sell mortgage, assign, surrender lease and Exchange the movable and immovable properties owned by the Trust.
 - t) To appoint local committees, adhoc-committees or other committees for any purpose as and when required consistent with the aims and objects of the Trust.
 - u) To co-opt members as the Board of Trustees as may deemed necessary.
- The Trust shall not carry on any business.

VIII. MINUTES, ACCOUNTANTS & AUDIT:-

The Trustees shall maintain true and correct accounts of the Trust and a correct record of their deliberations and shall have the accounts duly audited by a qualified Chartered Accountant.

IX. POWER TO ALTER RULES & REGULATIONS:

The Trustees shall have full power and authority to make after and rescind rule and regulations for the management and administration of the Trust only with the previous approval from the Director of Income-tax (Exemptions), Salem.

X. INCOME FOR THE TRUST:

The Trustees shall collect and recover the income of the Trust Fund and shall provide for all costs, charges and incidental expenses, including insurance premium, expenses for or ordinary repairs all other outgoing and expenses for the management and administration of the Trust. No part of the income of the Trust shall be distributed among the trustees by way of dividend or profit or otherwise.

XI. BANK ACCOUNT:

To open one or more bank accounts for the trust in its name with any bank or banks as the trustees may deem fit and deposit moneys of the trust in such accounts and to give instructions to the bankers as to persons entitled to operate thereon provided that until such instructions are given, the managing trustee shall be entitled and are hereby authorized to open one or more bank accounts for the Trust and to operate their on and to draw cheques thereon. The Bank account shall be operated individually by the Chairman of the Trust;

The Trust may Open Bank account in the name of the Institution/Organization founded by the Trust. Such Bank Accounts shall be operated by such persons authorized by the board of trustees from time to time.

XII. APPLICATION OF INCOME AND TRUST FUND:

The Trustees shall after providing for the above mentioned payments and disbursements, apply and utilizes the net income or the corpus of the Trust Fund for the benefits of the citizens of India without any discrimination on the ground of religion, Caste or creed or accumulate or put by other statutory notification thereof, after complying with the provisions of the Income - Tax Act 1961.

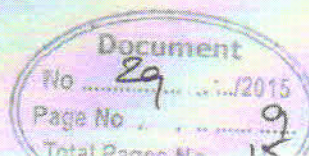
XIII. FOUNDER SETTLOR AND THEIR RELATIVES NOT TO BE BENEFITED:

XIV. REIMBURSEMENT OF EXPENSES MET BY THE TRUSTEES:

XVI. IRREVOCABILITY:

The Trust is irrevocable. However for the better fulfilment the object of the Trust may be dissolved by way of distributing the Trust Funds and properties of the Trusts to the other public charitable trust having similar object and enjoying 80G Exemption of the Income-tax Act.

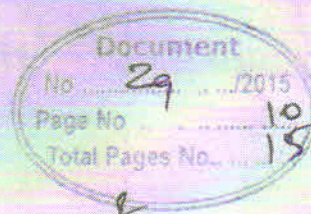
XVII. OFFICE OF THE TRUST:
